Letter from the President

Through Monica's leadership, the IASS has continued to grow and thrive in today's environment where it remains challenging to demonstrate the importance of professional societies. I particularly want to thank Monica for her leadership and mentoring as I become your next President. I also want to thank the ISI Executive Council and Permanent Office for their continuing support and dedication in keeping the IASS activities and administration going.

Our most recent July 2023 issue of the IASS journal: The Survey Statistician, celebrated 50 years of the IASS. We are grateful for the many contributions to the issue by our members and in particular, to past IASS Presidents. I would also like to thank those who are committed to the publication of the twice-yearly The Survey Statistician. They are the Editors: Danutė Krapavickaitė and Eric Rancourt; and the Section Editors: Peter Wright - Country Reports, Ton de Waal - Ask the Experts, Maria Giovanna Ranalli - New and Emerging Methods, Alina Matei - Book and Software Review; and Production and Circulation: Maciej Beręsewicz.

Over the past two years, the IASS has had a number of significant achievements to celebrate. Firstly, our highly impactful monthly webinar series includes on average over 100 participants and we are very grateful to our members who volunteer their time for statistical capacity building by delivering profoundly relevant and innovative webinars. We also awarded two prestigious prizes: the 2022 Hukum Chandra Prize and the 2023 Cochran-Hansen Prize and are deeply grateful to those members participating in the selection committees involved with these awards. We also supported the following conferences: ITACOSM2023 June 7-9, 2023; Workshop Nigeria, Ogun State July 13, 2023; and BANOCOSS2023 August 21-25, 2023. Finally, we have significantly expanded the IASS presence on Social Media: LinkedIn, Twitter and Facebook.

It is now time to pass on the reins to the new IASS EC. I am honoured to be your incoming President and I look forward to working with the 2023-2025 EC Vice-presidents: Eric Rancourt, Jiraphan Suntornchost, Annamaria Bianchi, Andres Gutierrez and the President – Elect Partha Lahiri. Over the coming weeks, we will be allocating the various roles of the EC members and will announce those in our next newsletter.

Another significant achievement of the previous EC was to develop the 2022-2023 Strategy Document which was ratified by the IASS General Assembly in 2022. - Issue a call for conference support 2024
- Continue with our successful monthly Webinar series
- Update country representatives and keep in regular contact to promote IASS in different countries
- Undertake individual and institutional membership drives
- Continue with The Survey Statistician publication and new editorial roles
- Issue monthly newsletters in mass mailings and on the IASS website including book of the month
- Continue promoting and posting IASS via social media channels

Finally, the new EC will plan a bespoke IASS satellite conference prior to the 2025 65th WSC that will take place in the Hague July 13-17, 2025 and will include all areas of research related to survey statistics and survey methodology. Announcement of the 2024 Waksberg Award Recipient

The 2024 recipient of the Waksberg Award (link: https://www150.statcan.gc.ca/n1/pub/12-001-x/award-prix-eng.htm [statcan.gc.ca]) is **Richard Valliant, Research Professor Emeritus, University of Michigan and Joint Program in Survey Methodology, University of Maryland**.

Professor Valliant will give the Waksberg Invited Address at the Statistics Canada Symposium in 2024 and write a paper planned for publication in the December 2024 issue of Survey Methodology.

The journal Survey Methodology (link: https://www150.statcan.gc.ca/n1/pub/12-001-x/index-eng.htm [statcan.gc.ca]) established in 2001 an annual invited paper series in honor of Joseph Waksberg to recognize his contributions to survey statistics and methodology. Each year, a prominent survey statistician is chosen to write a paper that reviews the development and current state of an important topic in survey statistics and methodology and reflects the mixture of theory and practice that characterized Joseph Waksberg's work. Joseph Waksberg was a giant in survey sampling for nearly seven decades, beginning at the U.S. Census Bureau in 1940 and then moving to Westat in 1973 where he served as Chairman of the Board from 1990 until his death in 2006. The award includes an honorarium made possible by a grant from Westat.

The author of the 2024 Waksberg paper was selected by a four-person committee -- M. Giovanna Ranalli (Chair), Jae-Kwang Kim, Kristen Olson, and Denise Silva -- appointed by Survey Methodology and the American Statistical Association.
